If a Foundation employee, board or committee member is involved in a discussion regarding a nonprofit or business entity with which he or she has an affiliation, he or she should: make a statement of disclosure of the affiliation, be available for discussion of the organization, and recuse himself or herself from any vote regarding the organization. Conflict of Interest Disclosure forms are filled out annually by all employees, board members and committee members.

There is no compensation paid to the directors and officers of the Community Foundation of Boone County; all of them are independent volunteers. The compensation for the paid staff, including the President/CEO, is reviewed by the personnel sub-committee of the executive committee (utilizes benchmarking data from other community foundations and charitable organizations). A recommendation is then made to the executive committee which conducts a further review and analysis of the proposed compensation and benefits before making a recommendation to the full board.
